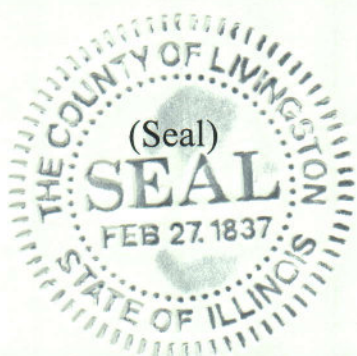

RESOLUTION NO. 2018-02-05

**TEMPORARILY CHANGE THE HOURS OF OPERATION FOR
THE COUNTY CLERK'S OFFICE**

WHEREAS, the County Board of Livingston County may change the hours of operations for the Office of the County Clerk pursuant to 55 ILCS 5/3-2007; and

WHEREAS, such action altering the hours of the Office of the County Clerk by the County Board shall be done by resolution passed at a regular meeting pursuant to 55 ILCS 5/3-2007; and

WHEREAS, the County Clerk of Livingston County is an Election Authority pursuant to 10 ILCS 5/1-3; and

WHEREAS, the date of the General Primary Election is March 20, 2018 and the General Election is November 6, 2018 as defined by the Election Code 10 ILCS 5/1-3; and

WHEREAS, Public Act 98-1171 was signed into law effective June 1, 2015, requiring Election Authorities to allow Same Day Registration in their offices on Election Day; and

WHEREAS, the County Board of Livingston County finds the County Clerk's Office shall be engaged in the duties of Election Authority on March 20 and November 6, 2018; and

WHEREAS, the County Clerk shall not be able to perform its normal duties of Clerk and Recorder in addition to the primary duties of the elections on March 20 and November 6, 2018.

NOW, THEREFORE, BE IT RESOLVED by the Livingston County Board that the Livingston County Clerk and Recorder's Office shall not perform any duty other than those pertaining to the **General Primary Election on March 20, 2018 and the General Election on November 6, 2018 and the office will be closed to all other services on said day with the exception of election related services.**

BE IT FURTHER RESOLVED that the County Clerk shall publish and post notice of said service closure.

This resolution shall be in full force and effect upon its passage.

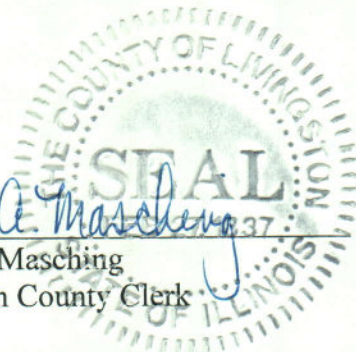
