IT Report for February 2015

The network path to the folder for Dictation Buddy files for Court 3 Judge and the secretary were repaired.

One of the county detectives involved with the investigation of child pornography had virus infected PC (Due to a review of pornographic files seized from a suspect). The PC was fixed by replacing the Operating system with a backed up image of the same PC.

The county Jail's Left Booking PC had to be repaired because of damaged Windows Operating System. Windows was re-installed with all the application software required at the booking station. A backup image of the system was also made.

Two workstations were infected by computer viruses and malware at Probation Department of the Law and Justice Center. The two PCs were cleaned of the infections.

IT department worked with June Slagel of Bookkeeping to install Fundware software update on the county's Fundware server.



The maintenance agreement with Safran MorphoTrust USA was renewed for the annual 9 to 5 coverage instead of 24/7 coverage. 9 to 5 is half the cost of 24/7. We never call for help in the night. The coverage is for the maintenance of the jail's Livescan Machine for \$5,068.00.

The county's email application support was renewed for one year with Cloud Sherpas at a cost of \$9,250.00.

Evidence data files burned on DVD from the jail was reconfigured to make it possible to play a video evidence for the State Attorney's office.

A new correctional officer, Jared Acklin was added to the Active Directory of the Sheriff's server for access to network and resources.



A network printer in Bookkeeping office had it's rollers replaced because it was worn out and was malfunctioning.

CIRBN, our internet service provider warned of a downtime from 7pm to 11:59pm on the 20th of January. Internet service was not restored until 2:30 am in the morning of 21st of January. This resulted in my being called at 1am and had to stay up until service was restored.

The annual support of Guard 1 plus was renewed with Time Keeping company at a cost of \$1315.00. This is the IP Downloader that the guards use to keep track of inmate counts at time intervals.

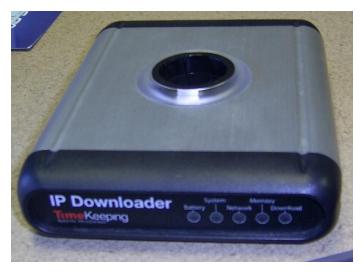


A new multifunction Brother network printer was purchased and installed for the Maintenance department to replace the

The settings on the server's Sonic Wall was reconfigured to make it possible for the Probation Dept. to access TASC lab results.

Updates were sent to NACo.org for Livingston County elected officials.

Internet Explorer was reconfigured on all jail computers to enable viewing of DVR's

The county's website was updated with ETSB/911 minutes.
