Appointment: Charles Cole – Reading Community Fire Protection District – The Committee reviewed a request for the appointment of Charles Cole to the Reading Community Fire Protection District. Ingles reported that he had met with Kristy Masching regarding whether these appointees have been providing proof of completion of the Open Meetings Act training. Ingles stated that he suggested that that become a requirement of appointment. Discussion took place. Appointment: James H. McCabe – Pontiac Rural Fire Protection District – Appointment: Duane Meister – Cullom Fire Protection District –

Hartley stated that in order to do so Mr. Kestner would need to be present at today's meeting to call for a reconsideration of the motion that was previously approved.

Review of Pending Litigation —Gerwin noted that the mitigation plan was approved in the House and has now moved onto the Senate. Gerwin stated that the legislation should be watched carefully. Steichen stated that the county should also continue to monitor the State's sweep of funds that are expected to be broad and considerably larger than the first set.
