The Committee reviewed the minutes of the November 2, 2015 meeting. *Motion by Runyon, second by Kestner to approve the minutes of the November 2, 2015 meeting as presented.* **MOTION CARRIED WITH ALL AYES.**

Appointments: ETSB - The Committee reviewed a request submitted by the City of Streator for the appointment of Scot Wrighton and Robert Turner, Jr. Chairman Fannin explained that one appointment will be done now, with one member of the ETSB resigning. The second appointment will be done following the next vacancy. The Committee then reviewed a request submitted by the City of Fairbury for the temporary appointment of RT Finney to serve while Mike Frickey is on medical leave. *Motion by Gerwin, second by Goembel to recommend the appointment of RT Finney to the ETSB.* **MOTION CARRIED ON VOICE VOTE.**

Appointment: Zoning Board of Appeals – Chairman Fannin stated that he would like to recommend that Richard Runyon be appointed to the Zoning Board of Appeals. Fannin stated that Mr. Runyon currently serves on the Regional Planning Commission which will leave a vacancy on that board. Fannin stated that he did have one interested party volunteer for the ZBA appointment. Fannin stated that he has questioned if that individual would be willing to serve on the Regional Planning Commission. *Motion by Goembel, second by Carley to recommend the appointment of Richard Runyon to the Zoning Board of Appeals.* **MOTION FAILED ON ROLL CALL VOTE.** Abstain: Runyon

Motion by Kestner, second by Gerwin to forward the appointment of Richard Runyon to the Zoning Board of Appeals to the full board with no recommendation. MOTION CARRIED ON ROLL CALL VOTE. All voted Aye; none Nay.
