Liquor License Renewals – The Committee reviewed the annual liquor license renewals. Hartley reported that Twin Creeks Golf Course is not applying at this time and is currently for sale. Monthly Department Report

Cook County / Federal Report – Superintendent Cox reported that there are currently 91 out of county detainees and 54 county detainees. Cox reported a Cook County billing of \$57,100, Northern at \$63,140 and Central District of \$13,695 for a total of \$133,935. Cox reported that transports for the month totaled \$12,582.35 for a grand total of \$146,517.35.

Pro-Active Report – The Committee reviewed the Pro-Active Report presented by Sgt. Hamilton.

Animal Control – The animal control report was distributed for the Committee's review.

Animal Control Ordinance Amendment – Deputy Hardyman presented recommended changes to the animal control ordinance. Hardyman stated that changes were made in regards to penalties for a public safety fee, dangerous dogs, and the population control fund. Hardyman stated that the changes were reviewed and approved by the States Attorney. Discussion took place regarding the use of the population control fund and oversight. *Motion by Mays, second by Ritter to table the issue and review the topic with the States Attorney.* MOTION CARRIED WITH A LL AYES.
