ILLINOIS PUBLIC WORKS MUTUAL AID NETWORK: Ruestman shared with the committee the desire of the highway department to join this mutual aid network. Metcalf has been in discussions with other counties that have joined and many have concluded that the ability to respond to an emergency or disaster greatly outweighs the small fee and required commitment. Schopp was present to discuss the value of joining this network of vast equipment and personnel resources should the need ever arise. Schopp has agreed to pay the annual fee of \$250 per year from his budget. The committee discussed the commitment by the county as well as the benefit the county could receive from the mutual aid. Ruestman stated that if there is no objection, we would be bringing the Intergovernmental Agreement and other necessary paperwork to the May meeting.
