# LIVINGSTON COUNTY BOARD MINUTES OF December 3, 2018, Organizational MEETING OF THE COUNTY BOARD

#### **OPENING**

County Clerk Kristy Masching called the meeting to order at 6:00p.m. in the Board Room at the Historic Courthouse at 112 W. Madison, Pontiac, Illinois.
