Design for Replacement of Existing Structure, Cost not to exceed \$30,000. Soil Borings, Right-of-way engineering and environmental coordination to be done at consultant's schedule of chargeable rates.

State Senator Jason Barickman held a meeting at the Livingston County Historic Courthouse to discuss the potential State Capital Bill. He wanted to hear from local public agencies as to what their priorities are. The common message was a sustainable increase in funds tied to an index such as COLA to make up for deferred maintenance is what is needed. Metcalf shared with the committee project specifics for Livingston County's Capital Request for Transportation which also includes how much additional revenues are needed to address several years of deferred maintenance to our infrastructure.
