

LIVINGSTON COUNTY BOARD
SHERIFF, JAIL & LICENSE COMMITTEE
MINUTES OF OCTOBER 8th, 2019

Committee Chair Kathy Arbogast called the meeting to order at 5:00 p.m. in the Committee Room within the Livingston County Historic Courthouse.

Arbogast called for any additions or corrections to the revised agenda with none requested.

Animal Control Ordinance Amendment – Deputy Hardyman was present to review the animal control ordinance amendments with the Committee. Hardyman stated that he spoke with States Attorney Yedinak and the language requiring collars will be removed from the ordinance. Hardyman stated that the registration fee will be \$10 and the intact fee, if applicable, will be \$10. Discussion took place regarding the spay/neuter program including operation safe, and the possible use of the mobile vet clinic. The amendment to the ordinance will be forwarded to the full board for approval.

Cook County / Federal Report – Sup. Inman reported that there are currently 60 Livingston County detainees, 50 from the Federal Northern District, 50 from the Federal Central District, 1 from the Northern Indiana District and 0 from Cook County. Inman reported the monthly billing for September at \$265,765.14.

Pro-Active Report – Lt. Hamilton was present to review the monthly Pro-Active Unit activity with the Committee.

Review & Approval of Bills – The Committee reviewed the bills submitted. Runyon questioned the purchase of a gun safe. Glowacki indicated that the gun safe was purchased for one of the school resource officers who wished to store his long rifle, as opposed to leaving it in the vehicle.
