



## **PAYMENT INFORMATION**

### **PAYMENT OF FINES, COSTS, INCLUDING EXTENSIONS FOR PAYMENT AND/OR TO COMPLETE COMMUNITY WORK SERVICE AND/OR EVALUATION & TREATMENT OR OTHER SENTENCING REQUIREMENTS FOR JUDGE MARK A. FELLHEIMER'S COURTROOM.**

Most individuals have been given a total amount including fines and costs during their court hearing. If not, or if you forgot your amount due, in order to obtain a printout of your total fines and costs in your criminal/traffic charges, following your court hearing, you may come to the Circuit Clerk's office to receive a copy. You may also view same on [www.judici.com](http://www.judici.com). It is your responsibility to contact the Livingston County Clerk's Office to request a printout. Failure to do so will constitute a defense to non-payment of fines and costs. Any bond money will be credited to the amounts owed.

You have been given a due date for payment of fines and costs. If you have not paid your fines and costs by the due date or have otherwise failed to appear for an extension of time to pay, your Court Supervision will be revoked and a conviction entered as to any petty offenses and/or the State's Attorney's Office could elect to file a Contempt petition or a Petition to Revoke your sentence. The Illinois Secretary of State could also be notified of your unpaid ticket(s) and a stop placed on your driver's license.

### **PRECEDURE TO SEEK AN EXTENSION TO PAY FINES, COSTS AND/OR TO COMPLETE COMMUNITY WORK SERVICE, EVALUATIONS & TREATMENT:**

Should you seek more time to pay your fines, costs and/or to complete community work service, evaluations & treatment, you must file a written motion, **PRIOR TO YOUR DEADLINE DATE**, seeking an extension at the Circuit Clerk's office at which time you will be given a court date to appear before a Judge to explain your extension request. The mere filing of a motion for extension does not automatically guarantee that your request will be granted. The Court will consider, among many factors, the basis for the request and whether you have made a good faith effort in paying finds and costs as well as completion of community work service, evaluations and treatment, if ordered in your case.

Request for extensions of time will not be heard or granted **UNLESS** a written motion has been filed **prior to the deadline date**. A form of a motion seeking an extension of time is available at no cost, at the Livingston County Circuit Clerk's Office.
