## LIVINGSTON COUNTY BOARD FINANCE COMMITTEE MINUTES OF NOVEMBER 4, 2020

Committee Chairman Tim Shafer called the meeting to order at 6:05 p.m. Pursuant to Public Act 101-0640 and the Gubernatorial Disaster Proclamation related to COVID 19, participation in this meeting was offered in person, through Zoom and by teleconference.

GLCEDC Recommendation for Property Tax Abatement – Technical Metals – Adam Dontz was present to request approval of a property tax abatement agreement with Technical Metals in Fairbury. Dontz stated that the abatement would be 100% for five years and 75% for years six and seven. Dontz reported that Technical Metals plans to construct a 25,000 square foot expansion estimated as a \$1.05 M capital investment. Dontz stated that Technical Metals exceeds the requirements outlined in the abatement program. Dontz noted that the City of Fairbury has already approved the abatement and the school board will meet later this month to approve. *Motion by Bunting, second by Fannin to recommend approval of the property tax abatement for Technical Metals.*MOTION CARRIED ON ROLL CALL VOTE. FY 2021 Budget, Capital Requests and Levies – Schwahn reported that the draft budget was amended to account for an increase in the insurance policy renewal. Schwahn stated that there was no need to increase the levy based on the increase but the ending balance did change. *Motion by Fannin, second by Slagel to recommend approval of the FY 2021 Budget, Capital Requests & Levies.* MOTION CARRIED ON ROLL CALL VOTE. Resolutions Accepting Sealed Bid Auction and Authorizing Transfer of Deed – Treasurer Nikki Meier reported that there were a total of eight bids received from the sealed bid auction that took place on October 2<sup>nd</sup>, one of which is for a mobile home. *Motion by Fannin, second by Earing to recommend approval of the resolutions authorizing transfer of deed.* MOTION CARRIED ON ROLL CALL VOTE.
