COVID Relief Stimulus Grant – Hartley presented a draft grant program developed in conjunction with Adam Dontz of the GLCEDC. Hartley reviewed the grant details which would be eligible for any Livingston County business who had not yet received any other form of funding related to COVID 19. Hartley stated that the applicant would need to demonstrate losses of at least \$15,000 over the second, third and fourth quarter. Hartley stated that the grant offers \$1,000 for each full time employee. A lengthy discussion took place with the consensus of the Committee being to increase the grant award to \$2,000 for full time and \$1,000 for part time. Discussion also took place regarding the definition of employee and expanding the program to acknowledge not only W2 workers, but also contract workers. Discussion took place regarding the ability of neighboring businesses to participate, with the consensus of the Committee being that to be eligible the business itself would need to be located within Livingston County. *Motion by Bunting, second by Fannin to recommend approve the of the COVID Relief Stimulus Grant as amended.*MOTION CARRIED ON ROLL CALL VOTE.
