# **PRESENTATION**

COVID 19 Status Update - Jackie Dever, Public Health Administrator reported the following items of interest: county dropped from an active rate of 17% to 8.2% with 167 active cases (down from the 300's); 2,841 cases with 50 Covid attributed deaths; conducting 50 rapid tests daily in conjunction with OSF at hospital site; rapid testing taking place at long-term care facilities now, 3 schools scheduled in January, at the Jail and increased testing at the prison; will be receiving detailed information on vaccine next week; federal requirement that the first shipment goes to the hospital; and the Moderna vaccine has received approval for use from the FDA. Discussion followed.

#### **AG & ZONING**

Zoning Map Case: ZM-4-20 – Dollar General-Zoning Classification Change (Resolution #2020-12-76) Committee Chair Jason Bunting reported that this case was requesting that a property map amendment be approved for a 1.5 acre of property near Saunemin which was currently zoned as AG, Agricultural, District, be re-zoned as a C2, Central Business, District property for a proposed Dollar General store. Chuck Schopp provided additional information regarding the site location, site plan and parking spaces. Schopp also noted that due diligence had been done with multiple sites being reviewed and considered with this property being the option Dollar General selected to pursue. He noted that the Zoning Board of Appeals and the Planning Commission discussions generally centered on the site location and their concerns regarding the safety of citizens from Saunemin walking or riding bikes to the store across the highway intersection of two main highways, Route 116 and 47. Schopp stated that the Regional Planning Commission opted not to make any recommendation due to safety concerns and the lack of time to study it further. The Zoning Board of Appeals tabled the discussion at their first hearing in order to allow the Farnsworth Group time to consult with IDOT to look into the safety concerns. At their next meeting they learned that IDOT had responded back that the safety issues weren't a priority for IDOT to pursue with a traffic safety study. Schopp stated that the Village of Saunemin was agreeable to this site because they felt that it was more acceptable to have the business in their area than not. The ZBA did make a decision to recommend to the County board that this proposal be approved. Paul Brown of the Farnsworth Group, representing Dollar General noted the process started a year ago, reviewed alternate sites and their shortcomings and addressed safety concerns. Saunemin Mayor-Bob Bradford addressed the board noting that the town board also had reservations regarding safety but felt that it would be in the best interest of the village to have the store located near Saunemin. He stated that this would create a few more jobs in their town and noted that Saunemin didn't get the opportunity very often to have a business locate there. Bunting reminded the board members that the action the board would be taking would be a motion and a second to change the zoning classification from agriculture to commercial. Discussion took place. Motion by Wilkey, second by Weller to approve Zoning Map Case ZM-4-20 and the corresponding resolution as presented. MOTION CARRIED ON ROLL CALL VOTE. **Zoning Map Case:** SF-4-20 – Slagel two lot Subdivision (Resolution #2020-12-77) Committee Chair Jason Bunting reported that this case was for a proposed 2-lot subdivision located on Rte. 24 on the northeast side of the curve between Forrest and Fairbury. Lot A would be would be a 2.45 acre parcel of

land containing the farming and livestock buildings to be retained by the owner.
