**COUNTY HIGHWAY 36 – DITCH RECONSTRUCTION:** Metcalf and Ruestman showed the progress of this project with photos. Trucking excess earth excavation was also discussed and the costs associated. There were no concerns expressed or motions made pertaining to the project.

**PROJECT UPDATES:** Riber is 99% complete with the bridge in Esmen Township. Resurfacing of CH 6 from Fairbury to Cropsey is approximately 98% complete with only a shoulder stone to be completed at various intersections and entrances. Iroquois Paving will begin the box culvert replacement in Fayette/Forrest next week and paint striping is planned to begin September 13th. Metcalf shared the design status of the new Maintenance Building. There was discussion around the use of an existing 12" clay tile system and the need to replace that tile with new material for future reliability in order to drain the new site properly. Soil borings and site survey will be completed shortly after the field is harvested.
