**NEW TANDEM TRUCK PURCHASE:** Due to shortages of parts in 2021, Kenworth canceled nearly all of the orders placed which included the County's. A new pricing schedule came out as a result of the shortage which is across the board for all makes and models. The increase is approximately 7% to the 2023 model of truck that has been now ordered in an effort to keep up with the Highway Department's fleet of trucks being replaced in a timely manner. This was in the budget and approved in 2021 as well. CIT will let us know when and if another truck can be ordered in 2022 based on the industry catching up to demands. **NEW MAINTENANCE BUILDING UPDATE:** Metcalf shared the ongoing process of preparing plans and specifications to have a letting for the project. A new entrance has been placed along at the proposed location to allow for fill and base materials to be delivered and stored. Exploration trenching has been completed to determine any conflicts with existing footing tiles of the office building. Location, type and size have been given to the design team.
