OBJECTOR'S PETITION

The objector, Ryan D. Bohm, states that he resides at 26498 N 1200 East Road, Cornell, Illinois 61319, that he is a duly qualified and registered legal voter of Livingston County, State of Illinois, the district in which Jay Mitchell, the candidate is to be voted upon, and that his interest in filing the following objections is that of a citizen desirous of seeing that the election laws governing the filing of nomination papers for the office of Sheriff, Livingston County, State of Illinois, are properly complied with, and that only qualified candidates appear on the ballot for said office as candidates for the General Election.

Therefore, he makes the following objections to the nomination papers of Jay Mitchell as an Independent candidate ("Candidate") for the office of Sheriff, Livingston County, State of Illinois, to be voted upon at the November 8, 2022 General Election.

1. Pursuant to 10 ILCS 5/10-3 governing Independent candidates for elective office, nomination papers for the office of Sheriff, Livingston County, State of Illinois, to be voted for at the November 8, 2022 General Election, must contain the signatures of not fewer than 867 duly qualified, registered and legal voters of said District collected in the manner proscribed by law. In addition, said Nomination Papers must truthfully allege the qualifications of the Candidate, be gathered and presented in the manner provided for in the Illinois Election Code, 10 ILCS 5/1-1, *et seq.* ("Illinois Election Code"), and otherwise executed in the form provided by law.

2. The Nomination Papers contain Petition Sheets with the names of persons who are not registered voters at the addresses shown opposite their respective names, as it set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the

heading, Column a, "Signer not registered at address shown", in violation of the Illinois Election Code.

3. The Nomination Papers contain the names of persons who did not sign said papers in their own proper persons, and said signatures are not genuine and are forgeries, as is set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading, Column b, "Signer's signature not genuine", in violation of the Illinois Election Code.

4. The Nomination Papers contain petition sheets with the names of persons for whom addresses are stated which are not in Livingston County, State of Illinois, and such signatures are not valid, as set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading Column c, "Signer resides outside district", in violation of the Illinois Election Code.

5. The Nomination Papers contain the names of persons for whom the signer's address is missing or incomplete as is set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading Column d, "Signer's address missing or incomplete", in violation of the Illinois Election Code.

6. The Nomination Papers contain the names of persons who have signed the Nomination Papers more than one time as is set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading Column e, "Signer signed Petition more than once at Sheet/Line indicated", in violation of the Illinois Election Code.

7. The Nomination Papers contain less than 867 validly collected signatures of qualified and duly registered voters of Livingston County, State of Illinois, signed by such voters in their own proper person with proper addresses, far below the number required under Illinois law, as set forth by the objections recorded in the Appendix-Recapitulation attached hereto and incorporated herein and the objection made therein are part of this Objector's Petition.

8. In addition to the foregoing objections, Objector alleges that Candidate's Nomination Papers do not comply with and in fact violate the mandates of Section 10-5.1 of the Illinois Election Code as Candidate's given or commonly known nickname is not "Jay" and that Candidate's use of the name Jay constitutes a name change.

9. Candidate's given name is John. The Statement of Candidacy and Petitions identify Candidate's given name as Jay. Candidate's given name is not Jay.

10. Candidate's nickname which he is commonly known as is "J", which Candidate has used and been commonly known as for over 20 years. Candidate has never used the nickname Jay before it appeared on his Nomination Papers.

11. Candidate's use of the given name Jay on the Nomination Papers rather than John constitutes a name change, whether by statute or common law.

12. Candidate's use of the name Jay has occurred in the last three (3) years before the last day for filing of his Nomination Papers.

13. Section 10.5.1 of the Illinois Election Code provides: "[i]n the designation of the name of a candidate on a certificate of nomination or nomination papers the candidate's given name or names, initial or initials, a nickname by which the candidate is commonly known, or a combination thereof, may be used in addition to the candidate's surname. If a candidate has changed his or her name, whether by a statutory or common law procedure in Illinois or any other jurisdiction, within 3 years before the last day for filing the certificate of nomination or nomination papers for that office, whichever is applicable, then (i) the candidate's name on the certificate or papers must be followed by "formerly known as (list all prior names during the 3-year period) until name changed on (list date of each such name change)" and (ii) the certificate or paper must be accompanied by the candidate's affidavit stating the candidate's previous names during the period specified in (i) and the date or dates each of those names was changed; failure to meet these requirements shall be grounds for denying certification of the candidate's name for the ballot or removing the candidate's name from the ballot, as appropriate, but these requirements do not apply to name changes resulting from adoption to assume an adoptive parent's or parents' surname, marriage or civil union to assume a spouse's surname, or dissolution of marriage or civil union or declaration of invalidity of marriage or civil union to assume a former surname or a name change that conforms the candidate's name to his or her gender identity. No other designation such as a political slogan, title, or degree, or nickname suggesting or implying possession of a title, degree or professional status, or similar information may be used in connection with the candidate's surname". 10 ILCS 5/10-5.1

14. The Statement of Candidacy and Petition Sheets contained in the Nomination Papers violate Section 10-5.1 of the Illinois Election Code as each contain the given name of the Candidate as Jay Mitchell, which Jay is not the given name of the Candidate. As such Candidate's Statement of Candidacy and each of the 103 Petition Sheets violate Section 10-5.1 of the Illinois Election Code making them invalid and of no legal effect and must be stricken.

15. The Statement of Candidacy and Petition Sheets contained in the Nomination Papers violate Section 10-5.1 of the Illinois Election Code as each identify Candidate as Jay Mitchell, which Jay is not a nickname by which the Candidate is commonly known. As such, Candidate's Statement of Candidacy and each of the 103 Petition Sheets violate Section 10-5.1 of the Illinois Election Code making them invalid and of no legal effect and must be stricken.

16. The Statement of Candidacy and Petition Sheets contained in the Nomination Papers violate Section 10-5.1 of the Illinois Election Code as each identify Candidate as Jay Mitchell, which is a name Candidate adopted or changed to in the last three (3) years before the last day for filing of his Nomination Papers. Candidate's adoption, change and use of the name "Jay" constitutes a statutory or common law name change which requires Candidate's Statement of Candidacy and Petition Sheets to contain the following language "formerly known as (list all

prior names during the 3-year period) until name changed on (list date of each such name change)". Candidate's Statement of Candidacy and Petition Sheets did not contain the language required by Section 10-5.1 of the Illinois Election Code. As such, the Statement of Candidacy and each of the 103 Petition Sheets violate Section 10-5.1 of the Illinois Election Code making them invalid and of no legal effect and must be stricken.

17. Additionally, Candidate is required to submit with his Nomination Papers an affidavit stating Candidate's previous names during the specified period and the dates or dates each name was changed. Candidate's Nomination Papers fail to contain Candidate's affidavit required under Section 10-5.1 of the Illinois Election Code. As such, Candidate's Nomination Papers violate Section 10-5.1 of the Illinois Election Code making them invalid and of no legal effect and must be stricken.

18. The Nomination Papers contain Petition Sheets, Nos.: 1, 7, 24, 30, 34, 48, 60, 64, 68, 69, 71, 73, 76, 78, 80, 81, 85, 90, and 93 which bear a circulator's affidavit which is not signed by the circulator in his/her own proper person, and not signed in the circulator's legal name, and such signatures are not genuine and are forgeries, and every signature on such sheets is invalid in violation of the Illinois Election Code. As such, these Petition Sheets violate Section 10-5 of the Illinois Election Code making them invalid and of no legal effect and must be stricken.

WHEREFORE, your Objector prays that the nomination papers of Jay Mitchell, a candidate for the office of Sheriff, Livingston County, State of Illinois, at the November 8, 2022 General Election, be declared to be insufficient and not in compliance with the laws of the State of Illinois, and that this name be stricken and that this Board enter its decision declaring that the name of Jay Mitchell as a candidate for the office of Sheriff, Livingston County, State of Illinois, be not printed upon the official ballot for the General Election to be conducted November 8, 2022.
