Hiatt reported that he had updated the request since the last meeting. Hiatt stated that the employee benefits unpaid had been paid to employees, but what was not paid was the agency expenses. Hiatt stated that there were premiums due for dental, vision and health insurance coverages. Discussion took place regarding the request. Consensus was to support the insurance premiums and outstanding local vendors.
