NEW MAINTENANCE BUILDING CONSTRUCTION SCHEDULE: Vissering has been working on the insulation and liner panels inside the building and the garage doors have been delivered. The new transformer work has been completed by ComEd with electrical lines being installed within the garage area very soon. The water line has been installed with the meter installation scheduled soon.

OTHER ITEMS: Metcalf asked the committee if they'd like to hold another letting for the bridge overlays on CH 8 that came in considerably over the estimate last fall with only one bidder. They agreed it would be okay to hold another letting. It was shared that Iroquois County Engineer, Joel Moore, passed away on April 21, 2023 suddenly at age 53. Construction has started on bridges in Broughton and Round Grove townships with sealcoat beginning in a few weeks, weather pending. The paving project on CH 8 and CH 6 is anticipated to begin in June. Metcalf shared the investigation that took place on SN 3294 in Indian Grove township. IDOT will be reviewing the information gathered and inform us if it should be remain Legal Load Only, posted or closed.
