The ACHIEVE Learning Center is operated under the umbrella of the Livingston County Commission on Children & Youth (LCCCY). A school year program and a 6–8-week summer school are offered. Call for dates. All teachers are certified.

### **MISSION**

Our mission is to help all students have success with learning. We focus on individual needs and provide one-on-one services. Our outcome is for the students to remain at grade level with their peers and to improve their personal self-esteem and worth.

### **SERVICES**

**Learning Assistance**: The center provides regular tutoring during school which is offered on Tuesdays and Thursdays. Tutoring services help students in areas of remedial academic needs, homework support, and learning style assessment for underachieving students. Plato, a web-based curriculum, can also be used as it utilizes educational standards including problem-solving skills, online assessment, interactive stimulation, and direct tutorial practice. The tutoring sessions are typically 1 hour.

<u>Pass 'Em On Program/Credit Recovery</u>: for students who did not complete course work successfully. To earn credit a home district professional will state the criteria of time and concepts to be learned. Parents are responsible for payments for the service and transportation. The Achieve Center will be responsible for teaching the concepts and notifying the district when the criteria has been met. The district will grant the credit.

**The Plato Program**: The Plato Program is a web-based curriculum used on the computer with children/youth who are struggling in school academically. This program assesses where the child is academically and provides an alternative format for learning. The Livingston County Commission on Children & Youth (LCCCY) purchases Plato licenses each year and it has been used in numerous different Livingston County schools.

<u>Diploma Recovery</u>: The Center has expanded to offer a Diploma Recovery program for those young adults who have dropped out of high school and recovery of a few courses/credits is more appropriate than for them to complete the whole High School Equivalency Course.

### **FEES**

Tutoring is \$30 per hour Credit Recovery is \$20 per hour Scholarships are available. Call the office for details.

### **PURPOSE**

# **SERVICES / ELIGIBILITY**

### HAMMITT SCHOOL

Special education, home intervention, and therapy to children with severe behavior disorders, emotional disorders, autism, pervasive developmental delays, and/or learning disabilities. Public school districts within a 60-mile radius refer children age 3-21 years at either our Hammitt Elementary or Hammitt Junior-Senior High Campus.

### POST LEGAL ADOPTION SERVICES

The provision of legally sanctioned information, mediation, counseling, and search assistance provided to all parties involved in adoptions facilitated by The Baby Fold.

### **ADOPTION PRESERVATION SERVICES**

Intensive counseling and support services to adoptive families in crisis. Contact the adoption preservation services unit at **309-454-1770** for further information.

### **FOSTER CARE**

Licensed foster homes provide traditional and specialized care to children in need of placement outside their homes. All foster parents meet state standards and receive initial and on-going training and support throughout a child's placement in their home. Services to the children are individually tailored to meet their needs. Support group available.

### **INTACT FAMILY SERVICES (IFS)**

IFS provides intensive casework for families at risk of abusing and neglecting their children. The goal is to stabilize and strengthen families and prevent the need for foster care placements.

### FEE SCHEDULE

- 1. Hammitt School Tuition is paid by referring school districts.
- 2. Post Legal Adoption Services No fee for mediation or provision of legally sanctioned information; search assistance fee; and counseling fees on sliding scale.
- 3. Adoption Preservation Services No fees.
- 4. Foster Care No fees to foster parents. Standard foster care rates are paid to foster parents.
- 5. IFS No fees, but must be referred by DCFS.

### **SERVICES**

### EARLY CHILDHOOD CARE AND EDUCATION

Children's Home + Aid provides a comprehensive array of services including Early Head Start, Head Start, Preschool for All, Home Based Care, and Child Resource & Referral programs. The agency's Early Childhood Centers provide childcare, education, health services and meals to children aged six weeks to six years old from approximately 6:00am to 5:30pm Monday through Friday. The Centers provide priority enrollment to children considered at-risk, including children of adolescent parents, victims of child abuse and/or neglect, and children from very low-income households.

### PARENT SUPPORT

**The Butterfly Project** provides children and families who have experienced domestic violence, family violence and community violence with a comprehensive continuum of care. The program addresses the issue of children's exposure to violence by providing community education, training and direct services to children, ages 0-13, who have been exposed to violence. Contact April Garcia for more information.

**The Children's Room** is a short-term waiting room at the McLean County Law and Justice Center where parents and guardians can bring their children (6 weeks – 12 years old) while they are involved in court-related matters. The Children's Room minimizes children's exposure to the trauma of court testimony. It also frees the court system of the noise and disruption associated with children in the courtroom.

**Crisis Nursery** provides emergency childcare for children birth – 6 years old. Open 24 hours a day, seven days a week to assist stressed and in-need families facing unexpected crisis.

**Scott Early Learning Center** serves children 6 weeks -5 years from families of all income levels and also offers Preschool For All – a free, half-day education program for up to 40 children between 3-5 years old who are from low-income families or who have developmental risk factors.

**Care and Share** offers support groups for generally anyone who is parenting: biological parents, non-custodial parents, single parents, stepparents, foster parents, grandparents raising grandchildren, and other relative/non-custodial caregivers.

**Family Visitation Center** provides a safe, neutral environment for supervised visits and exchanges between non-custodial parents and their children. Supervised visitation is solely for victims of domestic violence with no involvement with the child welfare system.

### AREA SERVED

Livingston, McLean, Woodford, Logan, and Ford counties in central Illinois.

### REFERRAL PROCESS

DCFS, Juvenile Court Services and others make referrals.

### **FUNDING**

Funding comes from contributions, school districts, and other referring agencies. Fees for services are paid by DCFS.

### **SERVICES**

### CENTRAL POINT OF ENTRY/SENIOR INFORMATION SERVICES

CCSI Case Coordination LLC provides information & assistance to the under 60 disabled population and over 60 population in Livingston County. This includes helping these populations apply for local, state, and federal programs and services, outside agency referrals, Senior Health Insurance Program Counseling, application assistance, and Healthy Aging Classes.

### CAREGIVER ADVISORY PROGRAM

The Caregiver Advisory Program provides assessments and support services to caregivers and care-receivers living in the community. This could mean a child caring for their aging parent, a parent caring for their disabled child, spouses or other family members caring for their loved one, or long-distance caregiving challenges. The Caregiver Advisor facilitates support groups to help educate and network caregivers in order to help them feel less socially isolated and introduce new coping skills. The Caregiver Advisor also makes referrals as appropriate for the specific caregiver/care-receiver situation.

### **GRANDPARENTS RAISING GRANDCHILDREN (GRG)**

This Caregiver Advisory is a fantastic resource for grandparents who have either temporarily or permanently been given the additional role of raising their grandchildren. This special population encounters a variety of challenging needs and unusual experiences with a great deal of financial strain. The Caregiver Advisor can help grandparents find resources and supports in the community that will help alleviate and address some of these needs. GRG Support Groups include childcare services to help facilitate accessibility.

### **SERVICES**

### **FAMILY HABILITATION**

This service offers contracted visitation services as well as parenting education, budgeting, and locating community resources for families of DCFS or other local child welfare agency cases.

### **COUNSELING**

Marital, pre-marital, family, financial and individual personality problem counseling are offered. There are also Family Life Education Programs. Counseling costs based on a sliding scale.

### INTACT FAMILY

This service is a 6-9 month program to help prevent out-of-home placement. It also offers in-home safety assessment and parenting education, budgeting, and community referrals.

### **FOSTER HOMES / ADOPTIONS**

These services are available for a child of any religion. Foster homes are for children 0-18 years of age. They currently have some foster homes in Livingston County.

### **YOUTH SERVICES**

Advocacy services are provided for Probation & Court Services.

### **SASS**

Screening, Assessment and Support Services (SASS) ensures all eligible children and adolescents receive a screening and assessment prior to any admission to a hospital for inpatient psychiatric care. Services include a 24-hour crisis response, ongoing therapy for 90 days following screening, and a coordination of services with schools, police, and other providers. (McLean County)

### **EMERGENCY RESIDENTIAL SERVICES**

260 E. Queenwood Rd. Morton, IL 61550 (309-636-7500). The population consists of youth without a place to stay; abused, neglected, pre-delinquent youths; and runaways. Short-term professional and social services for youths with goals to return home as soon as possible.

### **ELIGIBILITY**

No religious requirements. Anyone regardless of ethnic, religious and financial backgrounds is accepted.

# **FEE SCHEDULE**

Some services use a sliding fee scale; others are not fee based. Medicaid, private insurance, and private pay are accepted.

### **MISSION**

Child and Family Connections is the central point through which families enter the Illinois Early Intervention program. This voluntary home-based program provides free developmental screenings for all children from birth to 3 years of age. For children with developmental delays, specific medical diagnoses, and/or are at risk, an Individualized Family Service Plan (IFSP) may be implemented with the family's consent.

### **SERVICES**

For children with an Individualized Family Service Plan, services may include one or more of the following:

- \* Audiology
- \* Assistive Technology
- \* Developmental Therapy
- \* Physical Therapy
- \* Occupational Therapy
- \* Transportation
- \* Speech/Language/Feeding Therapy
- \* Nutrition Services
- \* Medical Diagnostic Services
- \* Nursing Services
- \* Service Coordination
- \* Social Work Services
- \* Hearing/Vision Services

Transition services to Early Childhood Education or other programs chosen by the family are provided for children approaching 3 years of age.

TANF (Temporary Aid to Needy Families) is the financial and medical assistance for needy families. The AABD (Aid to Aged, Blind, and Disabled) program provides medical assistance to aged, blind or disabled people.

### **FOOD STAMPS**

This program is designated to provide a supplement to the budget of low-income households. ### MEDICAL ASSISTANCE

The purpose of the Livingston County Commission on Children and Youth is to promote the development of an integrated, comprehensive community system of services for children and youth in Livingston County, particularly those who have special problems of emotional, physical and intellectual development, or who are not functioning successfully within the life of the family and the community.

### **PROGRAMS & SERVICES**

**The Family Resource Program**: This program provides assistance to low-income families or families with unexpected circumstances that arise. These basic needs may be rent, utility, food, transportation, medications, clothing, school supplies, furniture, or appliances. Before any payment is made or funds dispersed, all other options or resources are exhausted.

**Intensive Placement Stabilization (IPS)**: IPS serves children who reside in a foster home or children who have returned home from residential placement. In order to help preserve the placement, this program provides counseling, respite care, and mentoring along with hard services such as: clothing, furniture, recreational opportunities, etc. The program is funded by DCFS.

<u>The Family Support Specialist</u>: The Family Support Specialist serves children and families involved with the juvenile court system. The program can provide a mental health screening, case management, advocacy, truancy review, and service linkage. This program serves about 50 children/youth a year. It is funded by the Livingston County Commission on Children and Youth (LCCCY) and the Regional Office of Education.

**The Plato Program**: The Plato Program is a web-based curriculum used on the computer with children/youth who are struggling in school academically. This program assesses where the child is academically and provides an alternative format for learning. The LCCCY purchases Plato licenses each year and it has been used in numerous different Livingston County schools.

The A.C.H.I.E.V.E. Learning Center: The A.C.H.I.E.V.E. Learning Center is an afterschool/evening program which utilizes learning assistance, tutoring, homework support, credit recovery, and remedial and underachievement help. The Center is located in Pontiac, but serves students from anywhere in Livingston County. The A.C.H.I.E.V.E. Learning Center also uses the Plato Program. The LCCCY offers 8-10 scholarships a year to students referred in need of financial assistance. The Center has expanded to offer a Diploma Recovery program for those young adults who have dropped out of high school and recovery of a few courses/credits is more appropriate for them to complete than the whole High School Equivalency Course. The A.C.H.I.E.V.E. Learning Center usually serves about 10-20 youth a year.

**Livingston County Commission on Children and Youth (LCCCY)**: The LCCCY meets at least 6 times a year during the school year and involves 2 student representatives from each high school in the county and various people from different social service agencies, law enforcement, businesses, judicial system, school personnel, and the board members of the LCCCY. Reports are shared by the students on their respective schools, agencies share updates on their programs, along with speakers or discussion on relevant community topics are now offered.

This organization is a youth-adult partnership and leadership prevention program for adolescents focused on making positive healthy lifestyle choices. The name originates from the idea, "If I have a positive impact on you, you can have a positive impact on someone else and the effect SNOWBALLS." We focus on leading drug- and violence-free lives for ourselves and our community.

### **SERVICES**

- A. To provide factual information about drugs and alcohol upon which individuals may make responsible, rational decisions about the use of alcohol and drugs.
- B. To develop social and educational experiences designed to teach coping and decision-making skills.
- C. To provide activities to keep participants feeling good about themselves and their accomplishments.
- D. To help establish an environmental climate that promotes positive norms and attitudes towards social interaction and community relations.

### **SERVICES**

Livingston County Probation / Court Services works with juveniles and adults and provides the following services:

- 1. The supervision of individuals placed on probation by the Court. Referrals are made for medical, mental health, employment, educational, and prosocial recreational services. Probation Officers act as a liaison between the Court and other agencies working with the client. Like services are also provided to probationers of courts from other counties or jurisdictions who relocate to Livingston County.
- 2. Recovery Court programs including Drug Court and Veteran's Court.
- 3. Juvenile intake screening. Minors alleged by police to have committed a criminal offense are investigated to provide the State's Attorney with relevant information to aid in the prosecutorial decision and divert minors from the formal court system when appropriate. A Probation Officer meets with minor and family and contacts victims, involved Police Officers, and representatives of other involved agencies to gather information. Minors appropriate for diversion may be referred to various programs or be supervised formally.
- 4. Sentencing investigations to provide the Courts with background information concerning a defendant.
- 5. A Community Service Program to assist clients who are required to complete community service per a sanction from their Probation Officer or an order of the Court to find a worksite, and verification of all hours completed for the Court.
- 6. Electric Monitoring Programs of home confinement, GPS, and alcohol-use monitoring.

#### REFERRAL PROCESS

Most referrals come directly from the local Courts. However, law enforcement agencies, schools, other social agencies, and the community may also make referrals to the office.

#### **SCHOLARSHIPS**

Funding is also available for assistance with paying for the High School Equivalency exam (GED).

#### WORK BASED LEARNING

WIOA offers paid internship opportunities at area businesses and organizations to promote the development of good work habits. Participants are employed by Kankakee Community College, while the worksite provides the workload and supervision.

### MATERNITY SERVICES (PEORIA OFFICE ONLY)

Counseling services are provided for those persons dealing with issues related to an unplanned pregnancy. The maternity counselor may also arrange maternity home and medical services. Clients throughout the state are eligible for maternity services. There are maternity services in Livingston County (contact Peoria office for appointments) and no fees are charged.

#### **FOSTER CARE**

Families are licensed to provide substitute care for children from birth to 18 years of age who are temporarily removed from their birth families as a result of abuse, neglect, or dependency. Foster care is also provided for infants awaiting adoptive placement. Foster families are trained and licensed, receive regular supervision, and participate in an on-going support and training groups. No fees are charged to become a foster parent.

### **ADOPTION**

Families are prepared and licensed to provide permanent care for children who are unable to reside with their parents. "Waiting Children" who are in need of adoptive homes include children 6 years of age or older, sibling groups, children of any age who have developmental disabilities or emotions problems, and black infants and children. There are no fees for the adoption of waiting children.

Healthy infant, international, and private adoption services are available with a fee schedule depending on the type of placement. Search services to adult adopted persons and birth parents are also offered through this program as well as post adoption-counseling services to adoptive parents and their children. Persons interested in adoption services may contact the Peoria office.

### **SERVICES**

(Service Areas: McLean and Livingston Counties)

NEXT STEP/LISC FINANCIAL OPPORTUNITY CENTER (FOC): A collaborative partnerships offering bundled services to coach individuals and families toward achieving and sustaining their goals related to financial stability. Bundled services include employment coaching, certificate and academic courses, income supports and public benefits as applicable, housing counseling, and financial coaching. Next Step begins with values and attitudes about money to set action steps for behavioral changes toward short-term and long-term goals determined by each customer. Coaches provide customers with the tools to overcome barriers and provide encouragement and accountability to achieve benchmarks related to reducing debt, increasing income, increasing savings, and increasing their credit score.

Entrance into the Next Step/LISC FOC requires participation in an orientation. After attending an orientation, a one-on-one interview is scheduled where customers bring in all of their financial forms. One-on-one support is also available through Heartland Community College, if interested in pursuing a career or and educational pathway. MCCA and Heartland Community College are co-locating to provide bundled services to students and community members.

**HOUSING COUNSELING:** The Housing Counseling program offers pre-purchase counseling, and foreclosure intervention. This program also offers Homebuyer Education workshops, both, online and in-house. Anyone is eligible to take the class to gain invaluable information regarding the home purchasing process. The workshops offer a prospective, or existing, homeowner practical knowledge about homeownership. This will make the purchasing process easier and more understandable, as well as provide essential information every homeowner should have. In addition, counseling services for those facing the possibility of foreclosure are also available.

FIRST STEP/INCOME SUPPORTS: Income Supports is designed to help individuals and families help themselves move toward higher levels of self-sufficiency through a case management-based approach. The emphasis will be on gathering and providing information, conducting assessments, and referring individuals/families to MCCA programs and/or other community services. Program participants must by motivated and expected to participate in case management to identify needs, set goals, and make progress toward financial stability. Case managers will provide information, assessment, referrals, budget counseling, life skills education, and advocacy. Any service-related payments made on behalf of participants will be a by-product of case management services and working through a realistic, step-by-step plan of action. Service payments will reflect a variety of individualized needs and may include such circumstances as homelessness, rental needs, budgeting, credit repair, LIHEAP assistance, life skill needs, education, employment, and transportation. Payments are based on a combination of client's need(s), availability of agency funds, and access to collaborative resources from other local agencies.

**LOW INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP):** LIHEAP is a one-time payment towards utility bills for heat and electricity. The amount of payment varies based upon the household size and the amount of gross household income received during the past 30 days. Emergency assistance for shut-off utilities and furnace repair and replacement are also available through this program. The Percentage of Income Payment Plan (PIPP) is also available for income eligible households. This payment plan is designed to assist eligible clients monthly with energy payments. The utility companies that are participating in the program are Ameren, Nicor, and Commonwealth Edison.

MCCA also administers the ComEd Residential Special Hardship program for those households that have ComEd as their electric provider and are over the Energy Assistance program income guidelines. Customers who have had a crisis beyond their control, are on medical leave, or have low income due to disability, may apply for the program. This grant can be awarded once every 2 years. Please contact MCCA's Pontiac Office for eligibility.

**WEATHERIZATION (WX) ASSISTANCE PROGRAM:** After September 30, 2020, Tazwood Community Services, Inc. in Morton, IL will be providing Weatherization services to residents of Livingston County. Please call Tazwood at (309) 266-9941 for more information. Weatherization assists income eligible homeowners by

installing energy conservation materials in the home at no cost. The program may provide eligible Livingston County residents the following:

- 1. Sealing cracks with weather-strips and caulk
- 2. Insulating attics and walls
- 3. Repairing windows and doors
- 4. Upgrading home ventilation
- 5. Clean and tune the furnace
- 6. If cost justified, furnace replacement
- 7. Electrical and water conservation measures

**COMMUNITY BUILDING AND ENGAGEMENT (CB&E):** For this year (FY21) and last year (FY20), both, MCCA's focus is on Livingston County for the Community Needs Assessment (CAN). MCCA would like to engage with as many community members and stakeholders as is possible in Livingston County, as MCCA would like to learn, and help address, where the gaps are in community needs and resources. MCCA will work with neighborhood associations and help with their resident-led initiatives.

**COVID-19 RESOURCES (as funds are available):** MCCA now has resources to address a variety of needs for individuals and families affected by the COVID-19 crisis. Many community members have been laid-off, have had their income substantially reduced, are awaiting unemployment, are falling behind, or have lost income due to the need to stay home to care for children released from school or ill family members. Individuals and families, even if they have not been before, are now in need of services. Resources now available to eligible individuals and families include:

- 1. Rental assistance for up to three months. Maximums do apply.
- 2. Mortgage assistance for up to three months. Maximums do apply.
- 3. Temporary Emergency Shelter in hotel/motel for safety in documented crisis; maximum does apply.
  - 4. Utility assistance for electric, water, gas, propane—variety of programs depending on need.
  - 5. Prescription refill: assistance with one month of a prescription refill not to exceed \$300.00 per household.
- 6. Vouchers/Gift cards for food, hygiene products, diapers, formula, and detergents/disinfecting products
  - 7. Transportation funding such as bus tokens or gas cards for returning to work. Max \$50.00 monthly with verification of employment or attending on-site certified educational/vocational programs; maximum amount applies to this resource.
  - 8. Childcare expenses: childcare expense assistance for first month as individual starts or returns to employment; maximum amounts per family do apply.

9. Training funds to attend qualified certificate, job ready, and/or vocational training programs to reenter the workforce including CDL licensure, Certified Nursing, welding courses, and any certified vocational program.
