The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction", Adopted January 1, 2022, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures of Materials" in effect on the date of invitation of bids, and the Supplemental Specifications and Recurring Special Provisions indicated on the Check Sheet included here in which apply to and govern the material for Section 24-00000-00-GM / Combined Signs, and in case of conflict with any part, or parts, of said Specifications, the said Special Provisions shall take precedence and shall govern.

**DESCRIPTION OF PROJECT:** This project shall consist of furnishing various warning, regulatory signs and sign posts to the County of Livingston.

The Engineer shall be the County Engineer or his authorized representative.

**COMPETENCY OF BIDDER:** The Highway Committee of the Livingston County Board reserves the right to reject any and or all proposals and to waive technicalities.

**BIDDING INSTRUCTIONS:** The entire Proposal Bid Packet shall be returned with the prices for each sign written in the appropriate places. Suppliers are reminded that bid prices per sign for each sign designation shall include the sign and the shipping cost, F.O.B. to the Livingston County Highway Department. Enclosed within the bid proposal book are pages indicating the quantity and type of signs to be delivered. Suppliers who bid on signs must indicate a unit price for each sign designation listed or their bids will be disqualified.

The proposal guaranty shall be a certified check or a bank cashier's check made payable to the *Treasurer of Livingston County*.

**24"x 9" RURAL REFERENCE SIGNS:** The Unit Price for these signs shall be good for one calendar year from the date of the Award by the Livingston County Board. Separate orders from this Proposal will be made once per month as necessary. These signs shall be delivered within two weeks of the written order. Shipping costs of additional orders shall be included in the Unit Bid Price for this pay item. See attached drawing for suggested layout details.

**DELIVERY, PACKAGING AND SHIPPING:** After written notice of the bid award, the successful bidder shall furnish the entire balance of the specified material within sixty (60) days to the Livingston County Highway Yard in Pontiac, Illinois. Failure on the part of the material supplier to furnish the material within the time specified will be considered just cause to forfeit the proposal guaranty and void the bid award. If special circumstances require other arrangements on this point, they must be noted in writing at the time of the bid award.

Signs shall be packaged on individual pallets as indicated within the Proposal for each separate Packing List. Complete signs shall be packaged with appropriate slip sheeting to prevent damage while shipping. If delivery is made by truck, arrangements must be made 48 hours in advance in order that the County may arrange for receipt of the materials. Truck deliveries will only be accepted before 3:00 p.m., weekdays with no deliveries accepted on Saturdays, Sundays or holidays.

**CERTIFICATIONS:** Certifications from the aluminum signs base manufacturer and the sign sheeting manufacturers that all materials used for the products in the bids are in compliance with the specifications contained herein.

**MATERIAL REQUIREMENTS (SIGNS):** All parts or materials must be of current date and meet all specifications. This provision excludes surplus, re-manufactured and used products. The County of Livingston shall have the right to inspect any materials or components. Any items not complying with these specifications are subject to rejection at the option of the County of Livingston. Any rejected items shall be removed from the premises of Livingston County and/or replaced at the expense of the bidder.

- **GUARANTEES AND WARRANTIES:** The signs covered under this proposal shall be warranted for 10 Years by the Fabricator. **The back of each sign shall have a sticker identifying the Fabricator and the Year of Manufacture.** The warranty is requested in order to utilize one of the methods to assess and manage Retroreflectivity as will be required by the Federal Highway Administration. Where it can be shown that retroreflective sheeting supplied and used according to the sheeting manufacturer's recommendations have not met requirements, the sheeting manufacturer shall cover restoration costs for sheeting shown to be unsatisfactory life for each type of sign. This restoration shall be the replacement of the sheeting required to restore the sign face to its original effectiveness.
- **SIGN AND SIGN FACE:** The sign blanks, faces and legends shall conform to applicable sections of Articles 720 and 1091 of the "Standard Specifications." All sign faces shall be mounted on aluminum sheeting in accordance with the applicable material requirements found in these Articles. Type 1 signs (less than or equal to 9 sq. ft.) shall be mounted on 0.080 inch thick aluminum and Type 2 signs (over 9 sq. ft. and less than 24 sq. ft.) shall be mounted on 0.125 inch thick aluminum. Reflective sheeting for sign faces and legends shall be 3M.

The following Types of sheeting shall be used on the signs indicated:

- Type AZ - School Signs (Yellow-Green Fluorescent)
  - Construction Signs (Orange Fluorescent)
- Type AP - All Other Signs

**MATERIAL REQUIREMENTS (POSTS):** All parts or materials must be of current date and meet all specifications. This provision excludes surplus, re-manufactured and used products. The County of Livingston shall have the right to inspect any materials or components. Any items not complying with these specifications are subject to rejection at the option of the County of Livingston. Any rejected items shall be removed from the premises of Livingston County and/or replaced at the expense of the bidder.

- **1.12lb U-Channel Post, 7' Enameled, Type C:** This pay item shall consist of furnishing and delivering 7' long, 1.12 lb. Enameled Type C metal posts meeting the provisions of Article 729.02 of the Standard Specifications for Road and Bridge Construction. The work will be paid for at the contract unit price per each for 1.12lb U-CHANNEL POST, 7' ENAMELED, TYPE C.

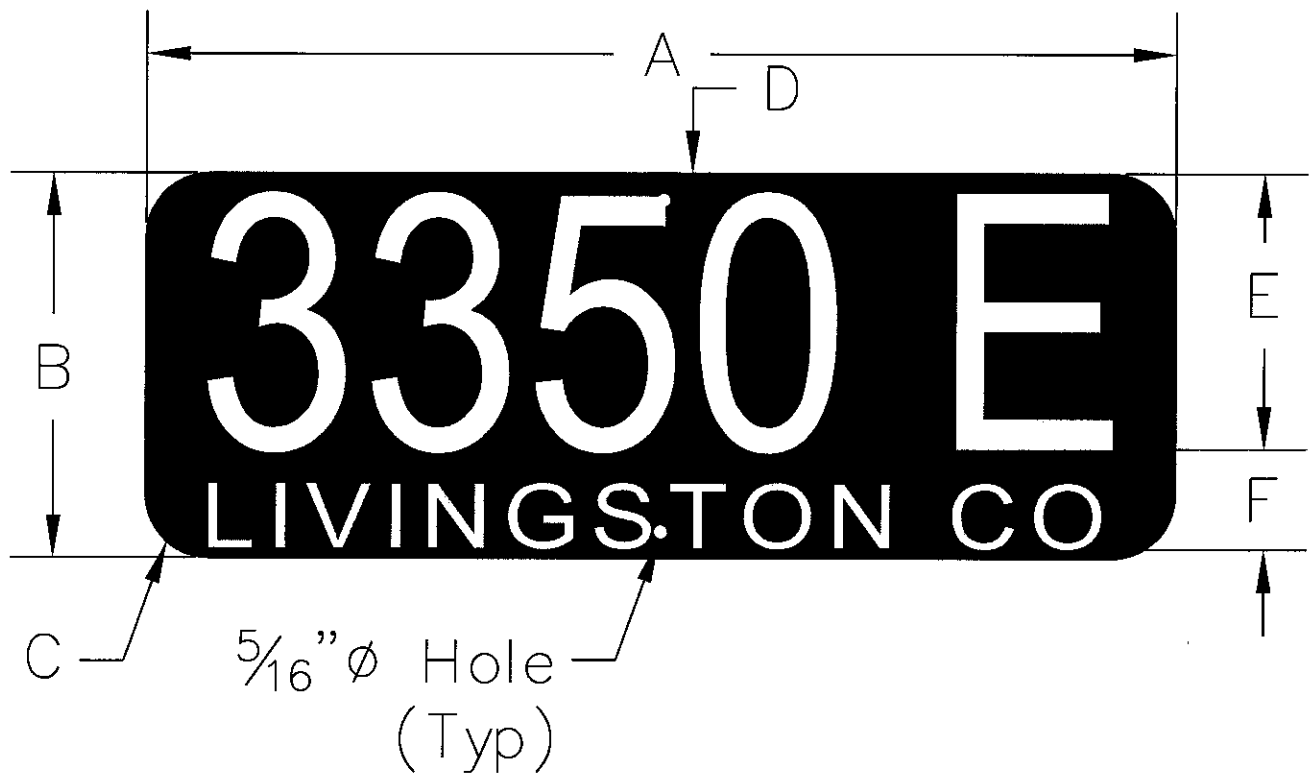
