Standing Rules Amendment - ESDA – Hartley reported that the ESDA Coordinator position has been separated from the Regional Planning & Zoning Department, noting that due to these changes Emergency Services should report to a different Committee. It was consensus of the Committee that Emergency Services report to the Sheriff, Jail & License Committee moving forward. *Motion by Fannin, second by Blackard to amend the Standing Rules moving Emergency Services to the SJL Committee.* **MOTION CARRIED WITH ALL AYES.**

Veteran's Assistance Commission Annual Report – Haerr reviewed the annual report with the Committee. Haerr reported that the VAC supported 16 veterans' requests for emergency rent, grocery and utility expenses. Due to the IDVA Office closing, the Commission filled a full-time Veteran Service Officer (VSO) position to help meet the needs, by recruiting the Assistant Superintendent. Haerr mentioned that the goal would be to hire another VSO to assist with claims. Haerr stated that the VAC updated the Commission's Bylaws in May to align with the changes in the 2023 MVAA, and are updating policies as well.
